HC3'S 2025 IMPACT: A LETTER FROM THE EXECUTIVE DIRECTOR OF HC3

HC3 Members and Partners,

2025 began with strong momentum and optimism and quickly unfolded into a year defined by rapid change, complex challenges, and meaningful progress across the health care landscape. Nationally, health care leaders navigated a demanding environment shaped by policy uncertainty, ongoing discussions around Affordable Care Act subsidies and Medicaid funding, accelerating technology adoption, and persistent concerns about affordability and access. At the same time, Chicago's health care ecosystem continued advancing equity-centered work through the Healthy Chicago 2025 strategic plan, reinforcing a shared commitment to reducing racial life expectancy gaps and improving community well-being across neighborhoods. Amid these national and local dynamics, the Chicago health care community has been inspiring to watch as we collectively met uncertainty with purpose, advocacy, and innovation.

Throughout the year, we hosted four exceptional quarterly summits, each attended by hundreds of stakeholders deeply invested in the future of health care in Chicago. These convenings extended their reach through expanded content on YouTube and LIVE podcast recordings, allowing us to share insights and learning with a broader audience across our community.

True to our mission, HC3 strengthened collaborations and built new partnerships. Highlights included Loyola University's Annual Health Equity Quest, a nonprofit showcase in partnership with 2Flo Ventures' Annual Equity Symposium, contributing to the Center for Health Innovation's Annual Health Equity Symposium and leading conversations at Sista Afya's Policy Conference. We also supported nationally recognized events including the State of Reform for Illinois, Women in Medicine's National Summit and Together.Health's national retreat and Dignity Grows National Summit on Period Poverty.


Our community partnerships continued to evolve in meaningful and impactful ways. We celebrated the opening of Chicago Integrated Health's first brick-and-mortar location, connected Honeysuckle Homes and other partners to Loyola's Pathways to program, supported community engagement efforts with the Campaign for Equitable Funding through events and



strategic advisory guidance, and advanced development and partnership strategies alongside Ashtech Wisdom. Together, these collaborations reflect a deep commitment across our network to strengthening equitable health outcomes throughout Chicago.
